- Or individual employees can use Comaea independently.


# **Accessing the Online Tool**

### Individual Access to Comaea

We will contact each of your individual named members and start the process for adding them to the Comaea system.

They will be asked to agree to the terms of use.

They will then receive their login details to the system.

We also provide guidance on how to carry out the assessment once they are ready to start.




#### **Corporate Access to Comaea**

To set up organisation access to the Comaea tool we need more details from you such as the hierarchy of the team and the manager's details.

Once we receive those we will then contact each one of the individual named members and start the process for adding them to the Comaea system.

We also provide guidance on how to carry out the assessment once they are ready to start.




#### **Manager Access to Comaea**

Managers of teams will also be given access to the Comaea system, and they will be able to:

- 1. Carry out their own self-assessment (if appropriate)
- 2. Review all the self-assessments their team has completed.
- Run several different reports on those assessments.
